BOLDROCCHI S.r.I. is a family-run company, founded on the principles of honesty, solidity, quality and continuous improvement with a strong sense of social responsibility. These principles are carried out by the Management and are shared by the same with the entire company organization.

BOLDROCCHI was founded in 1909 in Milan, by the engineer Luigi Boldrocchi. Over a century later, the company has matured and expanded, remaining totally in the Boldrocchi family, which continues to put the quality of its products and the satisfaction of its customers in the foreground.

BOLDROCCHI S.r.I. started its business with the production of centrifugal fans which still remains its flagship.

Today it designs, manufactures and installs industrial and ecological technical systems and their parts. The production includes centrifugal and axial industrial fans, centrifugal compressors, heat exchangers for electrical and process machines, industrial silencers, special dampers, silenced intake and exhaust systems for gas turbines complete with diverter by-pass damper, treatment systems and purification of gaseous emissions from industrial production and combustion.

BOLDROCCHI S.r.I., already certified ISO 9001: 2015 and OHSAS 18001: 2007, has provided for the adaptation of the Occupational Health and Safety System according to the ISO 45001: 2018 standard, as a tool for the optimization of management and production by so that its products and processes do not present significant risks for Health and Safety at Work.

During 2020 it defined the implementation of the Environmental Management System according to the ISO 14001: 2015 standard, towards an integrated HSE (Health Safety Environment) system. Aware that the environment is a primary asset, it pays attention in carrying out its work by planning and seeking in the activities a balance between economic needs and environmental needs, preventing risks, in compliance with current legislation.

The company has also adopted an Organizational Model pursuant to Legislative Decree 231/2001, including the special safety part and the special environment part.

Since 2014, the company has adopted a Ethical Code to formalize its commitment to operate according to fair competition practices and prevent conflicts of interest, sharing this commitment with interested parties.

The protection and respect of human rights are priority aspects in determining corporate strategic choices.

- 4) Identify and analyze the risks associated with the activities carried out for the preparation and supply of goods and services;
- 5) Identify and evaluate in advance any new risks regarding modification of activities and plants and the introduction of new processes and / or technologies;
- 6) Give priority to monitoring and risk assessment actions and internal investigations to protect the health and safety of workers and the environment, in order to significantly reduce the probability of accidents, injuries or other non-conformities, with the aim of zero accidents:
- 7) Promote communication outside and inside the Policy, objectives, programs and performances in the field of Safety and the Environment, maintaining a close dialogue with the various interested parties (customers, employees, suppliers, authorities, control, local community, etc.);
- 8) Identify specific company indicators that allow the control and monitoring first of all of the risk and of the degree of achievement of the objectives, measuring the trend of accidents, injuries and occupational diseases, relevant environmental indicators and specific trends in relation to the measures prevention and protection implemented with particular reference to corrective actions;
- 9) Pay particular attention to health surveillance activities, with the active involvement of the competent doctor in the worker's medical history activities;
- 10) Verify, by the Management, the Head of the Management System, the Function Managers, the continuous adequacy of the System and implement, where necessary, the appropriate improvements;
- 11)Continuously improve environmental performance and pollution prevention in carrying out all activities of direct and indirect relevance, defining targeted objectives and making the necessary resources available;
- 12) Define operating procedures that take into account the environmental aspects of each work activity and continue to raise awareness and educate staff;
- 13)Use the best available techniques in particular for replacement and improvement investments, within the framework of a correct policy for the use of company resources;
- 14) Reduce, as far as technically and economically possible, the environmental impact of its processes and activities;



- 15)Exercise processes with a view to constant attention and progressive reduction of energy consumption, protection of natural resources (including water resources) and biodiversity, as well as sustainable consumption of raw materials;
- 16)Encourage the use of natural resources and renewable energy also with a view to reducing greenhouse gas emissions;
- 17) Where possible, undertake to reduce waste production and maximize sending for recovery and recycling as an alternative to landfilling;
- 18)To create products that are attentive to the environmental impact from the perspective of the life cycle including the phases of use of the product and its end of life;
- 19) Pay attention to the reduction of defects and continuous improvement of products so that they are as safe as possible even for the customers they are intended for;
- 20) Adoption of environmentally friendly rules of conduct among suppliers;
- 21)Cooperate in the supply chain towards a shared commitment to a procurement process that is attentive to the demands of social sustainability, ethics and the protection of human rights.
